# Privacy Policy - information clauses regarding the processing of personal data in connection with the use of the F8M Foundation's websites

This Privacy Policy contains information on the processing of personal data in connection with the use of the website maintained by the F8M Foundation.

The Privacy Policy contains information required by the provisions of Regulation 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR).

The document contains the following information clauses regarding the processing of personal data.

- 1. Visiting and browsing the website.
- 2. Registration and participation in events.
- 3. Information about your rights.
- 4. Instructions for deleting personal data.

## 1. Data processed in connection with visiting the website

- a. Data: IP addresses, cookies and similar data about user activity or devices.
- b. The data controller is the F8M Foundation, ul. Kościuszki 4, 37-611 Cieszanów, rodo@8marca.org
- C. We process data for the purposes of:
  - i. enabling convenient use of the website
  - ii. monitoring abuses,
  - iii. informing about activities and opportunities for cooperation and support for the F8M Foundation
  - IV. conducting statistics, measuring quality and effectiveness,
- **d.** The basis for data processing is the necessity to implement the above-mentioned. purposes that result from the legitimate interests of the administrator.
- **e.** Legally justified interests consist in achieving the statutory objectives of the F8M Foundation described in the foundation's statute.

- f. The Administrator may make data available to other recipients only at the request of entities authorized by law or when it is necessary to implement the above. purposes, e.g. entities providing hosting, IT service or other technical support.
- **g.** The administrator stores data only for the time necessary to achieve the above. purposes, no longer than until you object to the processing.

#### 2. Data processed in connection with registration or participation in events

- a. Data: name and surname, e-mail address, name of the company/institution/organization/editorial office/university, position/student. In some cases, also country, postal code, city, voivodeship, landline phone, mobile phone, login details (e-mail address and password). For some people and events, a photo may be required..
- b. The data controllers (Co-controllers) are the F8M Foundation, ul. Kościuszki 4, 37-611 Cieszanów,
- C. The data will be processed for the purposes of:
  - i. event registration,
  - ii. identity verification when entering the premises where the event will take place and issuing an appropriate ID,
  - iii. granting access to the broadcast and rebroadcast of the event;
  - iV. marketing and communication by the F8M Foundation with the participant, in the form of written or electronic correspondence or using telecommunications devices (telephones, text messages) only if there is a legal basis for such action,
  - V. conducting statistics, measuring quality and effectiveness,
  - Vi. handling complaints and securing claims.
- d. The basis for data processing is the necessity to implement the above-mentioned. purposes that result from the legitimate interests of the administrator. In the case of certain data or specific types of processing that cannot be considered necessary to fulfill the above-mentioned purposes or in the case of purposes that cannot be considered sufficiently justified indicated separately in the appropriate data field or in the declarations of consent at the

- end of the registration form the basis for processing will also be the participant's consent.
- **e.** Legitimate interests consist in constantly improving the quality, increasing the availability of events and the number of event participants.
- f. The administrator does not share data with other entities.
- **g.** The administrator stores data only for the time necessary to achieve the above. purposes, no longer than until you object to the processing
- h. Providing data is voluntary, but necessary to register for the event, if you do not provide the required data, you will not be able to complete the registration process and set up an individual account in the registration system.

### 3. Information about your rights

In connection with the processing of personal data, the user (data subject) has the following rights:

- i. the right to request access to data,
- ii. the right to request rectification of data;
- iii. the right to request deletion of data,
- IV. the right to request data transfer,
- V. the right to request restriction of data processing,
- Vi. the right not to be subject to automated decision-making, including profiling,
- VII. the right to object to the processing of personal data,
- Viii. the right to withdraw consent at any time (e.g. by reporting to rodo@8marca.org) without affecting the lawfulness of processing based on consent before its withdrawal.
- iX. the right to lodge a complaint regarding the processing of personal data with the competent supervisory authority.

#### 4. Instructions for deleting personal data

a. The User has the right to request the deletion of personal data concerning him or her processed by the Administrator. A request to delete data should be sent to rodo@8marca.org.

To speed up the application processing procedure, the user may specify his/her request, indicating that, for example, he/she wants to delete the data or no longer wants to receive information related to the statutory purposes of the F8M Foundation. If there is no clear statement to what extent personal data is to be deleted, the Administrator may contact the user to confirm whether the user's request is tantamount to a request to delete his or her full data. At the request of the above The Administrator will respond immediately, no later than within one month, and if it is impossible to meet the request, the Administrator will provide the reasons.

The administrator is obliged to delete personal data if one of the following circumstances occurs:

- i. the data is no longer necessary for the purposes for which it was collected:
- ii. the user has withdrawn consent on which the data processing was based and there is no other legal basis for the processing;
- iii. the user has objected to the processing of data and there are no overriding legitimate grounds for processing or has objected to the processing of data for direct marketing purposes;
- iV. personal data were processed unlawfully;
- V. The Administrator is under a legal obligation to delete data.
